

CLASSIFICATION OF GOODS

Class	Goods
1	Chemical products used in industry, science, photography, agriculture, horticulture, forestry; Cleaning and bleaching preparations and chemicals for industrial use; detergents for industrial use; chemicals for dispersing and concentrating oils, chemicals for bleaching, purifying and separating petroleum and oils; brightening chemicals and substances not included in other classes; paste for the manufacture of artificial pearls; chemical products for staining glazing; manures (natural and artificial); fire extinguishing compositions; tempering substances and chemical preparations for soldering; chemical substances for preserving food-stuffs; tanning substances; adhesives and glues not included in class 16.
2	Paints, varnishes, lacquers; preservatives against rust and against deterioration of wood; colouring matters, dyestuffs; mordents; resins; metals in foil and powder form for painters and decorators, gold varnish, metal preservatives; mineral paints.
3	Cleaning, polishing, scouring and abrasive preparations; glass cleaning preparations; sanitizer; soaps and detergents (not for industrial use), preparations for dissolving grease (not included in class 1); preparations for removing stains and rusts; bleaching salts, polishing substances included in class 3; bleaching preparations and other substances for laundry use; soaps, perfumery, essential oils, cosmetics, hair lotions.
4	Industrial oils and greases (other than edible oils and fats and essential oils); lubricants; dust laying and absorbing compositions; fuels (including motor spirit) and illuminants; candles, tapers, night-lights and wicks; preservative oils for stone-work; illuminating waxes.
5	Medicinal, pharmaceutical, veterinary and sanitary preparations and substances; absorbent cotton (medical); medicated paper; medicated skin powder, first aid boxes; surgical bandages; distilled water; disinfectants; preparations for killing weeds and destroying vermin, children's and invalids' foods; plasters, material for bandaging; material for stopping teeth, dental wax.
6	Unwrought and partly wrought common metals; metal alloys, aluminum foil, metal bag fastenings, metal boxes not included in other classes; metal cases, safety cash boxes, safety locks, metal chests, metal stands; furniture casters, iron chains, copper rings, picture hangers, metal hat hooks, metal door knobs, ornaments of steel, staples, anchors, anvils, bells, rolled and cast building materials; chains except driving chains for vehicles; cables and wires (non-electric); locksmiths' work; metallic pipes and tubes; steel balls; horseshoes; nails and screws and other goods in non-precious metal not included in other classes; ores.
7	Machines and machine tools; motors (except for vehicles); machine couplings and belting (except for vehicles); large size agricultural implements; washing machines; mixing and grinding machines for kitchen use; mixers and juicers included in class 7; spray guns for paints; incubators; endless belts for machinery, bone crushers, cross cutting machines, current generators, machines for cutting glass, metal and stones, embroidery machines, grinding, drilling and sharpening machines included in class 7, hand presses.
8	Hand tools and instruments; cutlery, forks and spoons; side arms, adjustable wrenches, pliers, pointed arms, cutting bars, carving blades, branding appliances, grindstones not in class 7, knives of precious metal.
9	Scientific, nautical, surveying and electrical apparatus and instruments (including wireless), electronic instruments and apparatus; electronic cards; electronic integrated circuits; cards for cash dispensing machines; electronic accounting equipments; automatic teller machines and cards, accessories, fittings, parts and components thereof; coin or counter-freed apparatus; television sets and parts and accessories thereof, VCRs and VCPs; dry cells, batteries of all kinds, computer, computer software, computer programmes; hardware and accessories thereof; drives, printers modems; hard and floppy discs; interfaces; fax modems; website, CD ROMs, cards, discs, internetting communication devices; scanners; electric and electronic apparatus included in class 9, cash register calculating machines, advertising apparatus; fire extinguishing apparatus; alarms, photographic, cinematographic, optical, weighing, measuring, signaling, checking (supervision), life-saving and teaching apparatus and instruments; coin or counter-freed apparatus; phonographs; cash registers; calculating machines; fire-extinguishing apparatus.
10	Surgical, medical, dental and veterinary instruments and apparatus (including artificial limbs, eyes and teeth), apparatus for radiology, surgical knives, scissors and cutlery, x-ray apparatus.
11	Installations for lighting, heating steam generating, cooking, refrigerating, drying, ventilating, water supply and sanitary purposes, installations and apparatus for heating, cooling and filtering water or air and parts thereof; lighting fittings, electric bulbs, electric fans; water filters, water coolers, refrigerators, geysers, cooking apparatus included in class 11.

12	Land vehicles, motor cars, touring motor cars, motor vehicles; fittings and accessories for vehicles; safety belts for vehicle seats, decorative articles for vehicle bodies, vehicle door and window fittings, vehicle wheels, safety seats for children (for vehicles); motor carriages, sporting vehicles; air cars, luggage carriers and holders, carriage aprons, motor chassis, delivery vans.
13	Firearms; ammunition and projectiles; explosive substances; fireworks, sporting ammunition, gun carriages, cases, chains, and belts for cartridges, automatic weapons.
14	Precious metals and their alloys and goods in precious metals or coated therewith (except cutlery, forks and spoons); jewellery; precious stones; natural and artificial gems, pearls, semi-precious fine stones, diamonds, platinum, silver alloys, bracelets, gold and silver imitation ware, jewellery of artificial ivory, medals, articles plated with precious metals, horologic and other chronometric instruments, watches and watch cases and parts of watches.
15	Musical instruments (other than phonographs and wireless apparatus) and parts thereof; cases for musical instruments.
16	Paper and paper articles, cardboard and cardboard articles; printed matter, newspapers and periodicals, books; book-binding material; photographs; stationery, adhesive materials (stationery); artists' materials, paint brushes; typewriters and office requisites (other than furniture); instructional and teaching material (other than apparatus); playing cards, (printers') type and clichés (stereotype), menu cards, envelopes, advertisement materials and sheets, journals, catalogues, computer print-outs, magazines, paper bags, letter heads, calendars, diaries, chart, pens, pencils, drawings, engravings, etchings, cards of all kinds and description included in class 16; index cards, letter openers, memo pads, table napkins (paper), pamphlets, brochures, business papers, office equipments all being goods included in class 16.
17	Gutta percha, India rubber, balata and substitutes, articles made from these substances and not included in other classes; materials for packing, stopping or insulating; asbestos, mica, and their products; hose pipes (non-metallic), electric insulation material, rubber hose, insulating paper and gloves, asbestos paper, stuffing devices.
18	Leather and imitations of leather, and articles made from these materials, and not included in other classes; skins, hides; trunks and traveling bags and cases; parasols and walking sticks, harness and saddler, attaché cases, belts, pouches, key pouches, hand bags, purses, valises, wallets, umbrellas, purses; skins; hides; whips, traveling cases, suit cases, brief cases, vanity cases, articles of luggage and parts thereof, all being goods included in Class - 18.
19	Building and building materials, houses, huts and portable buildings, pre-fabricated structure, cabins, name-plates, natural and artificial stone, cement, lime, mortar, plaster and gravel; pipes of earthenware or cement; road-making materials; asphalt, pitch and bitumen; portable buildings; stone monuments; chimney pots.
20	Furniture, mirrors, picture frames; articles (not included in other classes) consisting of wood, cork, reeds, cane, wicker, horn, bone, ivory, whalebone, shell, amber, mother-of-pearl, meerschaum, celluloid, and substitutes for all these materials, animal claws and horns, stuffed animals, beds and pillows; wood boxes and cases not included in other classes, wood carvings, figures made of wood plaster, and wax; ivory and ivory ornaments.
21	Small hardware and hollowware articles (not of precious metal, nor coated therewith); combs and sponges; brushes (other than paint brushes), brush-making materials; instruments and material for cleaning purposes; steel wool; glassware, porcelain and earthenware not included in other classes; kitchen utensils and drinking vessels, milk boilers, thermally insulated containers for food, containers and cans included in class 21; trays and troughs; toilet sets; jars and jugs; kettles; vacuum flasks; ice boxes; bottles and bowls; pressure cookers (non-electronic); cookers of all types (other than electrically operated), kitchen stands; lunch boxes; flower pots and stands therefore, pans included in class 21.
22	Ropes, string, nets, tents, awnings, tarpaulins, sails, sacks; padding or stuffing materials (hair, capoc, feathers, seaweed); sacks, padding or stuffing materials, bags not included in other classes, fibers for packing, packing material for goods, stuffing, cushions and for like purposes (not being paper), packing canals and cloths, packing strings, wrappings included in class 22.
23	Yarns; threads, knitting cotton.
24	Textile piece goods including shirting's, suiting, saris, woolen cloth and blankets, tissues (piece goods);polyester woolen blended fabrics, satin and shawls in piece, quilts, bed, table and pillow covers, flannel upholstery, towels and handkerchiefs, velvet clothes, diapers, cloth trimmings, twilled fabrics, sanitary crape, jute clothes, water proof clothes.
25	Clothing, footwear's including boots, shoes and slippers, readymade garments and hosiery; clothing; fashion accessories included in class 25; ties; trousers, shirts, ladies undergarments including bra, panties, skirts, night dressings, children's clothing, caps, hats and bonnets; helmets; belts (clothing); swimwear; socks; aprons; napkins; gloves, coats.

26	Embroidery and embroidered goods, frills, lace and laceworks, ribbons and braid; hooks, buttons, press buttons, buckles, dress holders, coat hangers, tie holders, hooks and eyes; pins and needles; artificial flowers, needlework cases, hair nets, hair pints, wigs.
27	Carpets, rugs, mats and matting; linoleums and other materials for covering floors; wall hangings (non-textile), bath mats, stair carpets, ceiling coverings, textile door mats, mural hangings, leather cloth, table mats and all other goods included in class 27.
28	Games and playthings; gymnastic and sporting articles; cubes included in class 28; toys, dolls, board games, video games, toy vehicles, chess boards, scrabble (toy), building blocks (toys), musical toys, playing bowls, mechanical toys, ornaments and decorations for Christmas trees.
29	Meat, fish, shellfish, poultry and game; meat extracts; preserved, dried, canned, tinned and cooked fruits, vegetables; jellies, soups, essences, jams, eggs; milk and other dairy products; malted milk for food and foods included in class 29 prepared from milk; food stuffs for human consumption included in class 29; edible oils and fats; olive oil for food, vegetable preserves; pickles, butter; ghee; cheese; creams; vegetable soup preparations; food products made from fruits and vegetables; all kinds of chips and wafers, salmon, salad oil, sausages, all being goods included in class 29.
30	Spices, masala, curry powder, pepper, papad, honey, artificial honey, treacle, yeast, baking-powder, vinegar, sauces, permitted food flavors and colors, asafetida, rice, barley, besan, maize, wheat and wheat flour, cooking salt, coffee, tea, rava, mustard, tapioca, sugar, sugar juice, sweetening materials not in class 1, syrups, glucose, pulses of all kinds; cereals, preparations made from cereals, corn flour, cooking essences, ginger, pepper, breakfast foods, puddings, ketchup, instant food mixes, noodles, potato flakes, tapioca, wafers, ice cream; snack foods; bread and bread flour, buns, rusks, confectioneries, biscuits, pastry, sauce powders, chewing gums, chocolate, malt and malt preparations included in class 30.
31	Agricultural, horticultural and forestry products and grains not included in other classes; living animals; fresh fruits and vegetables; seeds; live plants and flowers; foodstuffs for animals, groundnut seeds; food grains; oil seeds; live animals; fruit nuts, kola nuts, peas, malt and extract of malt, edible lime (chuna); mukhwās; mouth fresheners, scented supari.
32	Mineral and aerated waters and other non-alcoholic drinks; beer, ale and porter; syrups, beverages and preparations for making beverages, non-alcoholic fruit extracts, fruit juices; soft drinks, sherbets, soda water.
33	All alcoholic beverages including wines, spirits and liquors included in class 33; fruit extracts with alcohol not included in class 32.
34	Tobacco, raw or manufactured; smokers' articles; matches.
35	Advertising; business management; business administration; office functions which also includes Career Profiling & Psychometric Assessments of employees, Counseling for working professionals, HR services, Personnel recruitment; Business Consulting, Designing of standard operating procedures for companies.
36	Insurance; financial affairs; monetary affairs; real estate affairs.
37	Building construction; repair; installation services
38	Telecommunications.
39	Transport; packaging & storage of goods; travel arrangement
40	Treatment of materials
41	Education; providing of training; entertainment; sporting & cultural activities which includes seminars, training, workshops, Career Profiling, Training Programs on Study Skills & Personality Development, Counseling for shaping one's career, career change or selecting the right career (for applicants from school students to working professionals).
42	Scientific and technological services and research and design relating thereto; industrial analysis and research services; design and development of computer hardware and software.
43	Services for providing food and drink; temporary accommodation which includes Accommodation; Rental of temporary Accommodation; Bar services; Cafés; Self-service restaurants; Snack-bars
44	Medical services; veterinary services; hygienic and beauty care for human beings or animals; agriculture, horticulture and forestry services.
45	Legal services; security services for the protection of property and individuals; personal and social services rendered by others to meet the needs of individuals.
